### Project Requirements

**Pocket Pets Project members who intend to exhibit their animals at the Adams County Fair must complete the following to remain eligible for fair entry and exhibition:**

1. Enroll in the Pocket Pets Project by the enrollment deadline.
2. Complete and turn in the Companion Animal Project E-Record by the deadline.
3. ID all animals in 4HOnline by June 1 deadline (project animal must be owned by ID deadline).
4. Attend Animals Record Book Interviews and present an up-to-date E-Record Book.
5. Enter fair classes online by deadline
6. Complete and turn in the Companion Animal E-Record by the deadline & supplement pages.

# Project Tips - *Pocket Pets*

## Additional Information - Animal Entry in 4-H Online

1. Beginning in 2016 - 4-H members will be required to enter their animals in the 4-H Online enrollment system. This page will help summarize the information required in this system.
2. All pocket pet project animals must be entered in the 4-H Online system no later than June 1st of the current project year.
3. Pocket pet project Members will enter their animals under the 'Small Pet' tab.
4. All "bold" items are required in 4HOnline, pictures are optional.
5. It is highly recommended any and all animals with the potential of attending Fair have ID in 4HOnline. If an animal does not have ID, it will not be allowed at Fair.
