**Premium Scale: Based on Number of Entries**

**RULES: (Also see Livestock, Equine, & Small Animal Rules)**

Cat Project members who intend to exhibit their animal(s) at the Adams County Fair must complete the following to remain eligible for fair entry and exhibition:

1. Enroll in the Cats Project by the enrollment deadline (found under 'activities' in 4-H Online).
2. Complete and file an Animal Care and Housing Form on 4HOnline by deadline.
3. ID all animals in 4HOnline by June 1 deadline (project cat must be owned by ID deadline)
4. Attend Animal Record Book Interviews and present an up-to-date E-Record Book.
5. Enter fair classes online by deadline.
6. Your cat must meet the vaccination requirements to be eligible to enter in the County Fair. (see premium book)
7. Complete and turn in E-Record book the Friday following Labor Day to the Extension Office.

Additional Fair-related rules are listed below as well as under each Division/Class:

1. Cats must have distemper and rabies shot prior to July 1, display a current tag, and show copy of proof of immunization receipt from D.V.M. to a Cat Superintendent the day of the show.
2. Exhibitor must own entries at least 60 days prior the start of the fair (June 1).
3. Exhibitor may supply own cage.
4. Cats in heat are barred from showing. Cats may or may not be neutered.
5. Exhibitor must be on hand to show cat during judging.
6. Cat's toenails must be clipped before entry, front and back.
7. Interview judging is required of all exhibitors just before judging. Those not interviewed are not allowed to exhibit their animal for judging.
8. A Special Contest winner will be selected from all cats entered in the Cat Division. All cats entered in the Fair are eligible to compete in the Special Contest. The criteria for this contest will be announced the morning of the show.
9. Exhibitor must complete a 4-H Record book interview and their book must be up-to-date to be eligible for exhibition. Please see Livestock, Horse and Small Animal Rules for more information.

**RECORD BOOKS**

**No Entry Fee**

1. Members must complete and turn in (by deadline) a record book for each species in which they exhibit at Fair. If a record book is not completed for each species exhibited, the member will forfeit premiums and be ineligible to exhibit that species at the next year's Fair.
2. Cat members complete Companion Animal E-Record and any necessary supplements.
