### RULES:

1. Use the FairEntry system to register - <http://adco.fairentry.com>. Entry fees must accompany entry form.
2. Fleeces **MUST** be in place by 4:00 p.m. Friday. No Exceptions.
3. Eligibility of Contestants. Any growers of wool may enter fleeces, but they must be entered in the name & address of the grower. W-9 forms may be requested if multiple entries originate from the same address and number of entries will be based on the Tax ID #.
4. Premiums will be limited to two entries in each class and no fleece can compete in more than one class.
5. **Eligibility of Fleece – In order to compete for prizes each fleece must:**
  - Have been shorn in the last 12 months prior to the fair.
  - Represent no more than 12 months growth except in the case of yearling fleeces when 16 months growth will be allowed.
  - In case of controversy concerning the number of month's growth of any fleece, the acknowledged rate of monthly growth of wool from different breed and types of sheep shall be used as a guide.
  - The Superintendent reserves the right to inspect any fleece entered if its eligibility is in question.
  - Fleece judged overage and/or found to contain parts of other fleeces will not be allowed to compete.
6. **Qualifications - Any fleece entered for competition in the Adams County Wool Show shall be discriminated against if:**
  - Showing any paint or tar brands (soluble branding fluid permitted.)
  - Showing excessive dung locks or tags.
  - Discolored by excessive moisture or cotted.
  - Showing a weak staple or break in fiber.
  - Containing any excess burrs or other vegetable matter.
7. **Preparation of Fleeces** – It is recommended that exhibitors pack fleeces in a clear plastic bag rather loosely so as not to impair their character or attractiveness. Each fleece must be tagged with this information: breed, sex, number of month's growth, and name of exhibitor.
8. Superintendent reserves the right to combine classes and/or sections depending on the number of entries.
9. If Exhibitors are eligible for both the 4-H and Open Wool Shows; Fleeces may only be entered in 4-H or Open Class wool. NOT BOTH.

### RULES:

2. The Adams County Make It With Wool Expo is open to anyone who is interested in showcasing their skills with wool fabrics, yarns and fibers
3. All entries must include proof of fiber content of the fabric or yarn (end of bolt information or wrap from skein. The proof of fiber content must be submitted to the Adams County Extension Office with the entry fees by Friday, July 14, 2017.
4. The fabric or yarn used to construct the garment must be *at least 60% wool or specialty wool fiber*. Specialty wool fibers include alpaca, angora, camel, cashmere, llama, mohair and vicuna.
5. Articles exhibited in previous years are not eligible to be exhibited again. Only finished, clean articles will be accepted.
6. Include your name on each item entered
7. ***Exhibits must remain intact until Monday, August 7, 2017. All exhibits will be released on Monday, August 7, 2017 between 4:00p.m and 6p.m.*** Exhibits must be signed for upon release. If exhibits are removed prior to Monday, August 7, 2017 premium money will be withheld.
8. The Al Lesser Building will be closed to the public Monday, July 31, 2017, while the judging is taking place. The building will open to the public on Wednesday, August 2, 2017 at 5p.m.
9. Guards will be on duty at all times to insure the safety of all exhibits, but at no time will the management be responsible for any loss or damage to property.
10. Adams County Fair Rules will apply.
